1. National Aquaculture Development Authority of Sri Lanka (NAQDA) is a body corporate established under National Aquaculture Development Authority Act No. 53 of 1998 for the development and management of aquatic resources and aquaculture industry.

The Chairman, Department Procurement Committee, National Aquaculture Development Authority of Sri Lanka now invites sealed bids from eligible Bidders for the execution and completion of the following works.

3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the Institute for Construction training and Development (ICTAD/CIDA) Registration in the grade given above as per Public Finance Circular No 03/2020 clause 3.1 (i),3.1 (ii)

4. Domestic Contractors are eligible for a 5% margin of preference in the comparison of their Bids with those of bidders who do not qualify for the preference. As per Public Finance Circular No 03/2020 (i) 5% special preference will be given for public enterprises for financial evaluation.
5. The Bidder shall possess a valid certificate issued by the Registrar of Public Contract in accordance with the Section 8 of Public Contracts Act No 03 of 1987 for every Bid which exceeds tenderable amount of Rs. 5 million. **Complying for the PCA 01 will be a qualification for award of the contract and PCA 02 certification mandatory before come up to the agreement.**
