Complying for the **PCA 01** will be a qualification for award of the contract and **PCA 03** certification mandatory before come up to the agreement.
06. Bids shall be valid for Ninety – One (91) days from the deadline of bid submission.

All bids must be accompanied by a bid security issued by a commercial bank approved by Central Bank of Sri Lanka as Specified in the Bid Documents and must be delivered to **Tender Box No:04** at the address given below in accordance with the general conditions on or before the dates mentioned above.
